### 4. FIRST AID MEASURES

---

**Description of first aid measures**

**General advice:** First Aid responders should pay attention to self-protection and use the recommended protective clothing (chemical resistant gloves, splash protection). If potential for exposure exists refer to Section 8 for specific personal protective equipment.

**Inhalation:** Move person to fresh air; if effects occur, consult a physician.

**Skin contact:** Remove material from skin immediately by washing with soap and plenty of water. Remove contaminated clothing and shoes while washing. Seek medical attention if irritation persists. **Notes to physician:** Maintain adequate ventilation and oxygenation of the patient. Exposure may increase "myocardial irritability". Treatment of exposure should be directed at the control of symptoms and the clinical condition of the patient.

If the temperature rises there is danger of the vessels bursting due to the high vapor pressure.. Vapours may form explosive mixtures with air..

### **Advice for firefighters**

## 6. ACCIDENTAL RELEASE MEASURES

### Exposure controls

When prolonged or frequently repeated contact may occur, a glove with a protection class of 3 or higher (breakthrough time greater than 60 minutes according to EN 374) is recommended.
